Businesses allowed to open include restaurants & bars for indoor dine-in, gyms, fitness studios, and community centres and more with restrictions effective Friday, July 17 at 12:01 a.m.

Canada Emergency Wage Subsidy (CEWS) To Be Extended Until December

This morning the Government of Canada announced its intention to extend the CEWS program until December. Details on the extension are expected to be released later this week. We commented that news of the extension was positive, but a successful CEWS update must also expand revenue eligibility and provide absolute clarity and consistency about the criteria for eligibility. Policy Update Following Fiscal Snapshot

Emergency measures introduced to assist Canadians and businesses because of the COVID-19 pandemic have come at a great cost. The total bill, which still is not known, must be monitored closely and transparently moving forward. With diminishing fiscal capacity, the country must begin retooling its economic fundamentals. Canada needs a clear plan to restore private sector growth, starting with a tailored strategy and timetable for safely reopening. Governments Of Ontario And Canada Provide Additional Insurance Coverage For Farmers

Ontario farmers, already enrolled in an eligible production insurance plan, who suffer from crop losses due to labour disruptions during the 2020 growing season will have access to further insurance coverage through Agricorp. The added insurance coverage will include:

- Inability to attract sufficient on-farm labour due to COVID-19
- Illness or quarantine of on-farm labour and the producer due to COVID-19

Farmers will be expected to notify Agricorp as soon as possible if they experience COVID-19 related labour disruptions that are having an impact on their crops

This week, the Prime Minister and Cabinet Ministers met for a virtual Cabinet retreat to discuss how we move forward as Canadians from this global pandemic. They spoke about the concrete actions they will take to fight racism in Canada, prepare for a potential second wave of COVID-19, and how to safely restart and rebuild the economy.

The path forward will continue to focus on the health and safety of people, while we continue to support hardworking business owners and entrepreneurs like all of you.

WEEK IN REVIEW

Wednesday, July 8th

On Wednesday, Minister Morneau <u>provided</u> an economic and fiscal snapshot – showing Canadians where we are now and our plan to stabilize and rebuild the economy in the weeks and months to come.

Our government made the decision early on to step up and help all Canadians through this time of need. Our support has meant millions of Canadians have been able to put food on the table, keep a roof over their heads, and support their families.

Nearly 3 million Canadians have kept their jobs because of the wage subsidy, almost 690,000 business owners have benefitted from the \$40,000 interest-free CEBA loan, and over 8 million Canadians (including entrepreneurs and self-employed people) have been supported by the Canada Emergency Response Benefit.

Thursday, July 9th

On this day, Minister Bibeau <u>announced</u> that our government, in partnership with the Government of Quebec, will together invest over \$1 million to provide targeted to support fish farmers in the province as they navigate the challenges of COVID-19

Friday, July 10th

On Friday, Minister O'Regan announced that our government will provide up to \$30 million to help cover the additional safety measures costs that small and medium-sized businesses in the forestry sector have incurred as a result of COVID-19. Faced with the challenges of both maintaining the manufacturing of essential products and ensuring seedlings are planted on schedule amid COVID-19, federal, provincial, and territorial governments – together with industry – worked collaboratively to quickly put in place measures to protect workers and communities.

Also on this day, Ministers Bains and Anand <u>visited</u> the GM Factory in Oshawa. GM was among the many companies that raised their hands and offered to retool their operations, and started producing #MadeinCanada PPE like surgical masks to help Canadians and our frontline healthcare workers fight against COVID-19.

DECLARATION OF EMERGENCY EXTENDED TO JULY 22

• In consultation with the Chief Medical Officer of Health, the Ontario government has <u>extended</u> the provincial Declaration of Emergency under s.7.0.2(4) of the <u>Emergency Management and Civil Protection Act</u> to July 22, 2020.

CANADA'S ECONOMIC AND FISCAL SNAPSHOT 2020

- On July 8, the federal Minister of Finance presented an economic and fiscal snapshot following Canada's
 response to the COVID-19 pandemic and delaying the 2020 federal budget in March.
- The federal deficit is projected to hit \$343.2 billion this fiscal year, comparable to spending during the Second World War. The federal debt will exceed \$1.2 trillion by the end of the fiscal year.
- Since the start of the pandemic, the federal government has spent more than \$231 billion on aid packages and health and safety measures for Canadians.
- Encouraging signs show the worst of the economic shock is behind us as the economy gradually reopens. While there is a major deficit, Canada is still expected to maintain its low debt advantage among G7 countries. More details *here*.

NO EXTENSION OF CURBSIDE PICK-UP & DELIVERY FOR CANNABIS RETAILERS

- The Ontario government has not made permanent the emergency order to authorize cannabis retail stores to offer curbside pick-up and delivery of products purchased online or over the phone.
- Ontario should have a competitive market for cannabis curbside pick-up and delivery should be made
 permanent to allow the private sector the necessary tools to compete against the illicit market, while creating
 jobs and economic growth.

ADDITIONAL UPDATES

- Today on **July 9**, the Ontario Government announced they are expanding access to reliable broadband and cellular service in underserved and unserved parts of the province. The application for the \$150 million *Improving Connectivity for Ontario* program (ICON) opens today. *Learn more*.
- On **July 8**, the Ontario government introduced the <u>COVID-19 Economic Recovery Act</u>. Click <u>here</u> for more details on this announcement.
- On July 7, the Ontario government passed <u>Bill 171, the Building Transit Faster Act, 2020</u>, which enables the
 province to expedite the process of building Ontario's four priority transit projects. The four projects include
 the all-new Ontario Line, the Yonge North Subway Extension to Markham and Richmond Hill, the improved
 three-stop Scarborough Subway Extension, and the Eglinton Crosstown West Extension to Pearson airport.

- On **July 3**, the Ontario government invested \$3 million to provide free online health and safety training to Ontarians. Up to 100,000 job seekers can now take free online workplace health and safety training through Employment Ontario. *Learn more*.
- On **July 3**, the Ontario government issued a new emergency order and amended another under s.7.0.2 (4) of the *Emergency Management and Civil Protection Act*, which will allow municipalities to quickly pass temporary bylaws for the creation and extension of patios and allow covered outdoor dining areas to serve customers. *Learn more*.

Chatham-Kent Small Business Recovery Grant Program

The Municipality of Chatham-Kent has established the Small Business Grant Recovery Program to provide a grant of up to \$5,000 to immediately assist small businesses who have been adversely affected in their revenue streams by the COVID-19 pandemic. Chatham-Kent Municipal Council and Administration recognizes the intense and severe financial hardship that has crippled small businesses due to the need for Public Health restrictions to slow the spread of COVID-19.

This Recovery Grant is intended to assist small business owners in their immediate needs to prepare their small business, store or restaurant in order to protect employees and staff members as they reopen for business. The grant fund pool is \$200,000 with available grants for businesses of up to \$5,000. Depending on the demand for this grant, amounts may be lower but equal for all successful applicants.

Applications will be accepted until Thursday, July 16th, 2020.
